At MBP an effective quality assurance management system is maintained to drive continual improvement within the organisation which is aligned to meet the requirements and compliance of the following standards; ISO 9001:2015; ISO 14001:2015; GMP+B3; ISCC EU; RSB EU RED; MarinTrust and the Marine Stewardship Council.

To achieve continual improvement MBP must learn from technology, partners, research, customers, suppliers, key stakeholders, and investigate complaints effectively to prevent reoccurrence. A total quality management system will be maintained to ensure document control.

These will be specific to the quality aspects and impacts of the organisation; measured for improvement; achievable; relevant to the quality management system, and in line with the standards held by MBP and regulatory requirements; and time bound.

MBP are committed to improving customer satisfaction; improving supplier performance; as well as increasing employee satisfaction.
