MBP has developed expertise providing services to turn one industry's by-product into another industry's raw material. The aim is to achieve sustained, profitable growth by providing services that consistently exceed the needs and expectations of customers. MBP is committed to minimising the environmental impacts of its business operations and seeks to maintain and continual improve its business resilience to environmental risks and impacts.

The aim of the organisation is to maintain a superior level of environmental performance through the adoption and integration of recognised environmental management best practices into business operations. MBP will comply with and where practical exceed, all relevant environmental compliance obligations across all its group locations and meet all other applicable environmental requirements and voluntary standards, including the UN Global Compact.

At MBP an effective environmental management system is established, implemented, and maintained, which is aligned to meet the requirements and compliance of ISO 14001:2015. The management system is regularly monitored and reviewed to drive continual improvement in environmental performance.

MBP has sustainability as a core company value and will ensure that sustainability considerations into wider business strategy and decision making are integrated. MBP requires every employee to act responsibly and contribute to every aspect of improving sustainability and environmental performance. MBP will promote a sustainable approach to business, and will seek to develop new markets, which add value to our business, our suppliers and customers, whilst undertaking consideration of the wider global impact of all our activities. MBP is committed to open communication and dialogue with our supply chain members and stakeholders to help identify opportunities to minimize the environmental impacts throughout the lifecycle of a product.

MBP are committed to the protection of the environment, through reducing the use of natural resources, improving the efficient use of those resources, minimising waste, and preventing pollution in order to preserve the environment and biodiversity.
